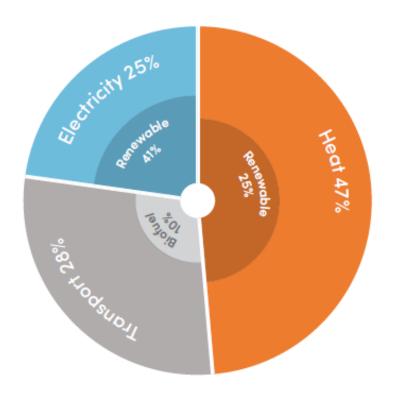

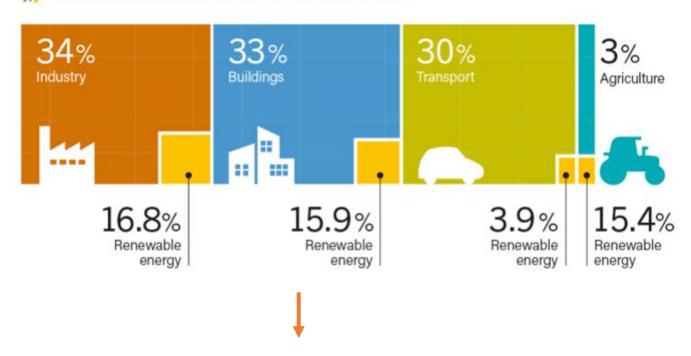


HEAT IS HALF of our energy needs

Total final energy and total modern renewable energy share, by energy carrier, European data (Source: Eurostat for year 2022)



Renewable Share of Total Final Energy Consumption, by Sector, 2021



80% of energy needs = HEAT

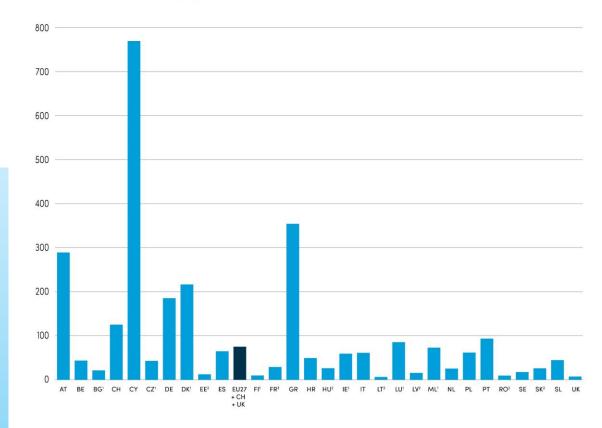


SOLAR THERMAL: Market Developments

- Sales growing since 2018 (except pandemic)
- Total installed capacity growing for 3 decades



Use of Solar thermal per capita in kW_{th} per 1000 capita



More than **10**million rooftops in Europe are equipped with solar thermal & thermal storage

Total installed capacity in Europe (mainland): 40.5_{GW}

That's 58 million m² of collectors

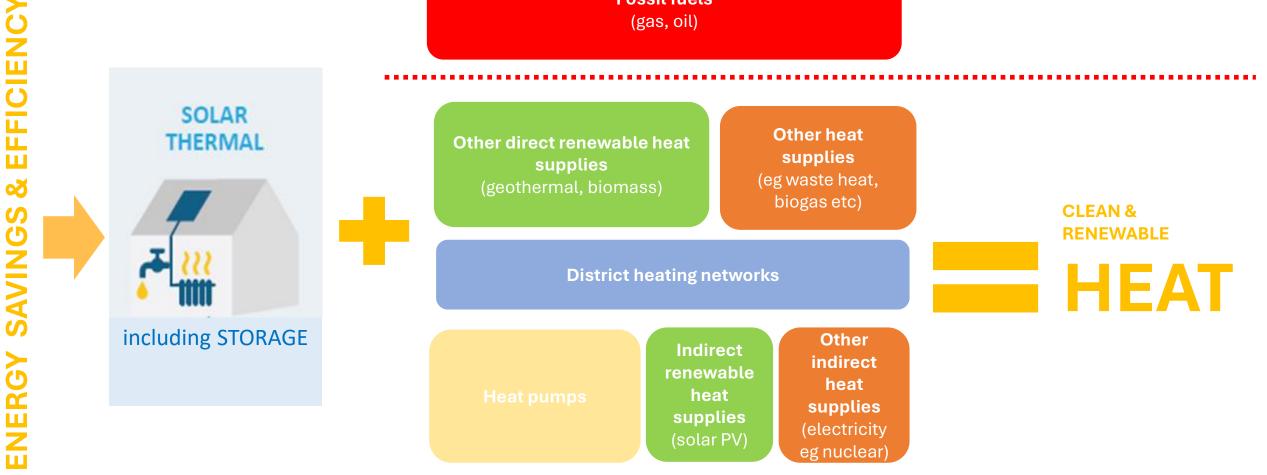

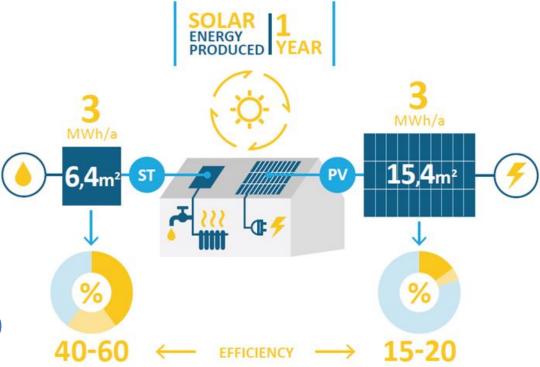
*in case of major renovation, action requiring a permit, works on the roof, or installation of a technical building system (i.e. heating system)



Good guidelines for a fair transposition

EPBD guidelines/Solar Mandate:

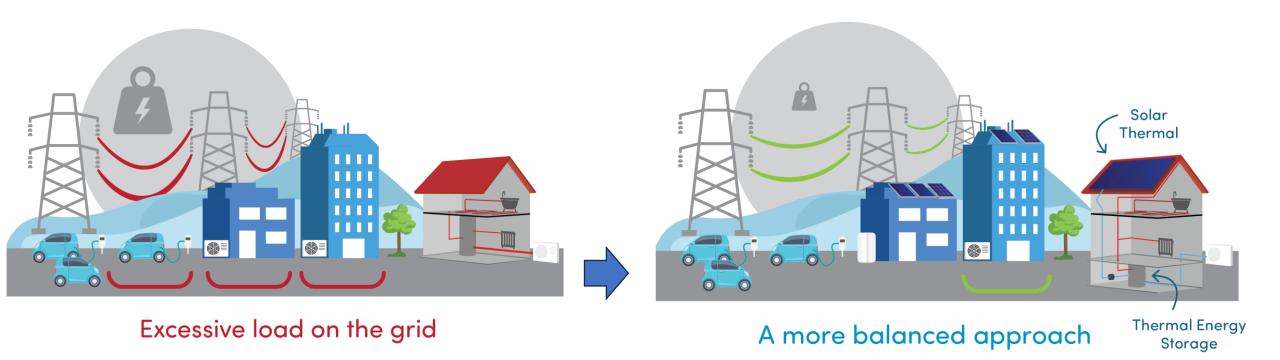
- This is a mandate for BOTH photovoltaics & thermal, incl ST and PVT
- Fair national frameworks to be used when drafting their national transposition such as:
 - "Energy produced" (per available area) rather than (just) the rooftop area
- \Rightarrow e.g.: 30 watts per m2 of rooftop are available
- ✓ Heat and/or electricity generation
 ⇒ Allow combined use of rooftop, including hybrid panels (PVT)
- Stakeholder consultations
- Flanking measures, incentives and monitoring





Solar Thermal:

Off grid, decentralised, efficiency booster, hybridising with heat pumps





In conclusion

Solar Thermal:

- Has definitely its role in the heat decarbonisation agenda
- Current legislative package = clear opportunity => Implementation is critical
- Fair treatment of all technologies is key Fair competition
- Awareness is key Work with all partners, one-stop-shops etc
- Enabling conditions to support the adoption of the most efficient/suitable solutions (finances, skills)
- All Renewable Energy Sources are needed!
